Class B - *Major Employers:

50 - 100	\$750 Dues Investment

Class C - *Financial Institutions:

\$15 per million in assets up to \$10 million	(\$150 minimum Dues Investment)
\$10-\$30 million	= \$300 Dues Investment
\$30-\$50 million	= \$450 Dues Investment
\$50-\$80 million	= \$600 Dues Investment
\$80+ million	= \$750 Dues Investment

Class D - *Self Employed Legal & Medical Professionals: \$150 plus \$75 per additional professional in office (Example: 2 doctors practicing out of one office, dues would be \$225 for the Business Membership)

Class E - *Insurance & Real Estate: \$150 per firm plus \$40 per additional agent in office (Example: 1 real estate broker with 4 agents, dues would be \$310 for the Business Membership)

Class F - *Lodging: (Motels/Hotels/Bed & Breakfasts)
